**It is a condition of Membership in BHCFA that you add BHCFA as an additional Insured on your Boat Insurance Policy. Please supply BHCFA with a Certificate of Insurance showing that BHCFA is an additional Insured on your policy.**

New Active Members should be aware that you will be expected to participate in Association activities including attending semi-annual Spring and Fall Meetings and assisting with promotional activities such as manning trade show booths by signing up for a shift or two at the BHCFA booth or table.
